

NOTICE TO BIDDERS

Repairs to 2019 Disaster Damages
Main Open Ditch, Drainage District No. 2
Clay County, Iowa

Time and Place for Filing Sealed Proposals. Sealed bids for the work comprising the repairs as stated below must be filed before 9:00 A.M. on January 26, 2021, in the office of the County Auditor, 300 West 4th Street, Spencer, Iowa.

Time and Place Sealed Proposals Will be Opened and Considered. Sealed proposals will be opened and bids tabulated after 9:00 A.M. on January 26, 2021, in the Board Room of the Board of Supervisors at 300 West 4th Street, Spencer, Iowa, for consideration by Board of Supervisors at its meeting. The Board of Supervisors reserves the right to reject any and all bids.

Time for Commencement and Completion of Work. Work on the repairs shall commence upon approval of the contract by the Board, and as stated in the Notice to Proceed. All work under the Contract must be completed, per Iowa Code Section 468.101, on or before May 28, 2021. Damages in the amount of \$200.00 per day will be assessed for each day the work remains incomplete.

Bid Security. Each bidder shall accompany its bid with bid security, as defined in Section 468.35 of the Iowa Code in the amount equal to five percent (5%) of the total amount of the bid. It is the sole responsibility of the bidder to see its proposal is delivered to the Jurisdiction prior to time for opening bids, along with the appropriate bid security sealed in the separate envelope identified as bid security and attached to the outside of the bid proposal envelope.

Contract Documents. Copies of the project documents are available for a price of \$25.00 per set. This fee is refundable, provided the plans and specifications are returned complete and in good usable condition, and they are returned within fourteen (14) calendar days after the award of the project. Preference of Products and Labor. Preference shall be given to domestic construction materials by the contractor, subcontractors, material, men, and suppliers in performance of the contract and further, by virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

Sales Tax Exemption Certificates. The bidder shall not include sales tax in the bid. The County Auditor will distribute tax exemption certificates and authorization letters to the Contractor and all subcontractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

Payment. Payment for work done will be in accordance with estimates approved monthly by the Engineer and in Drainage Warrants issued by the Drainage District, which, if registered and stamped "not paid for want of funds ", shall bear interest at a rate fixed by the Board not to exceed the maximum set by law in accordance with Chapter 468 of the Code of Iowa, as amended. The Board reserves the right to issue Drainage District Improvement Certificates pursuant to Chapter 468 of the Code of Iowa, as amended, which certificates may be given in exchange for outstanding warrants issued to the Contractor or to the holder thereof. Said warrants to be surrendered, if called by the Board, in exchange for Drainage District Improvement Certificates which shall be taken by the Contractor or holder at par and shall bear interest at a rate fixed by the Board not to exceed the maximum set by law in accordance with Chapter 468 of the Code of Iowa, as amended.

Progress payments will be made in an amount equal to ninety percent (90%) of the work completed. Final payment will be made not less than thirty (30) days after completion of the work and acceptance by the Board, subject to the conditions and in accordance with the provisions of Chapter 468 of the Code of Iowa, as amended.

PROJECT DESCRIPTION. The project includes lining approximately 1,450 LF of open ditch bank with 1,450 tons of riprap along with associated bank shaping and 200 CY of bank fill under riprap, minor soil choking of riprap, and seed & fertilizer on the ditch bank above the riprap to be covered with approximately 2,175 square yards (SY) of anchored erosion control blanket. The project also includes approximately 285 LF of eroded sediment relocation (channel excavation), 730 LF of bank shaping with no riprap, seeding & fertilizing, and other miscellaneous items of work.
